In 2010, The Prem Rawat Foundation expanded its Food for People (FFP) with a grant to a nonprofit organization in Accra, Ghana. TPRF's model program is now in its 6th year of operation in one facility in Bantoli, India; Dhading District in Nepal. The FFP program provides nutritious hot meals , clean water, and hygien education to children and ailing adults in impoverished communities. This program provides the impetus for families to make the transition out of extreme poverty into an upward trend of economic stability.

FOOD PROGRAMS: In 2010, including 2 grants for the FFP program (Nepal and Ghana), TPRF made 9 grants to support programs to assure nutritious meals for children in seven countries. Grants included 3 to provide food and water fo over 200 children orphaned by violence and disease in Kasese, Uganda; 1 grant providing a school meal program for 135 nomadic children in Niger; 1 grant for a school meal program, including nutritional education for parents, for over 100 Mayan children in Kunche, Mexico; 1 grant to help fund food and supplements for over 700 severely malnourished children and adults in Cambodia; and 1 grant to provide food for 3 months for over 5,000 Pakistani refugees from civil violence returning home after living in IDP camps.

WATER FOR LIFE PROGRAMS: In response to urgent needs for water, in 2010 TPRF awarded 3 grants to provide easily accessible clean water to

thousands of people in Tanzania, Southern Sudan and Morocco. These 3 grants ensured convenient access to clean water for over 3,000 people by helping to construct safe water wells (Sudan), bore holes and hand pumps and build a distribution system to bring water into homes.

DISASTER RELIEF: In 2010 TPRF supporters responded generously to the request for relief to a number of natural disasters worldwide with 10 grants to 5 countries. Haiti - TPRF made 4 grants totalling \$190,000 through 3 organization to aid earthquake victims. 4 grants were for 1) Pakistan - In response to the worst flooding in 80 years, TPRF made a grant to WaterAid to distribute safe water. Other grants were made to support survivors of the Chilean earthquakes, displaced people from the floods of Thailand, and a meal program for the Peruvian children displaced by floods and mudslides.

The Prem Rawat Foundation expanded its Peace Education Program in 2010 to support the many initiatives that have been making Prem Rawat's message of peace available in prisons in the last five years.
